

Terms and Conditions of Membership 2021-22

- **Full membership of PDBKA** includes membership of CBKA with the right to attend all CBKA meetings, membership of the BBKA including third-party and product-liability insurance, and Brood Diseases Insurance (BDI) for up to three colonies.
- ***Branch-only membership** is for those who do not have bees/ or do not wish to register for CBKA/ BBKA membership or BDI through PDBKA.
- *Additional options

a) Cumbria Beekeepers Associate Membership (CBKA)

b) Country Member: includes membership of CBKA and BBKA, but no insurance cover.

- Members' spouses, partners and dependent relatives may attend branch meetings and events.
- Benefits through membership to the affiliated organisations apply only to the named member (eg BBKA insurance, BBKA News, voting at CBKA AGM)
- Membership expires **31 December** . To ensure continuity of registration with BBKA and BDI Insurance, prior to the commencement of the summer season, members are required to renew their membership by **January 31st**.
- Membership benefits commence when subs have been paid (except when the Brood Diseases Insurance premium is paid after the end of March, in which case cover does not commence until 41 days after the premium is paid)
- Names, addresses, telephone numbers and E mail addresses of members are recorded on an electronic data retrieval system. As required by current General Data Protection Regulations, these will be deleted when membership has ceased for a period of 12 months, or at the request of a member at any time after membership has commenced. Members may request a copy of their information at any time.
- Members will be able to update their data at any point by contacting the Data Protection Officer and/ or, the Treasure and the Communications Secretary. Individuals can also request that their data be updated where it is inaccurate or incomplete. Any requests for data to be updated will be processed within one month.
- Members' contact details are used by the PDBKA Officers for the purpose of PDBKA administration and the promotion of local membership networks.
- The contact details of Full Members are passed on to the CBKA and BBKA for their administration needs, and to the National Bee Unit and the Bee Inspectors who have a statutory duty for monitoring bee health across the UK.
- The contact details of the Trustees and the Apiary Management Team are passed onto the administrators at Acorn Bank (National Trust) .

Privacy Statement: PDBKA stores membership details in a secure digital filing system accessed only by the designated PDBKA Trustees and on the BBKA/ BDI electronic data system.
